

TEMPORARY RESIDENTS PROGRAM

FACT SHEET - NEW ARRIVALS FROM LEBANON

Welcome to New South Wales (NSW), Australia. We understand these are difficult times, and we thank you for choosing the NSW Department of Education to deliver a welcoming, and quality education program for your child during your stay in Australia.

Temporary Residents Program

The Temporary Residents Program gives advice and support to enrol temporary residents into NSW government schools. The program accepts enrolment in primary school and high school from Kindergarten to Year 12 in consultation with the accepting school.

Visa requirements for your child

Children from Lebanon must hold a current valid visa to reside in Australia and meet specific travel, entry and residency conditions determined by the Australian Department of Home Affairs.

If your child holds visa subclass 600

The NSW Department of Education will waive the tuition fee for newly arrived children from Lebanon who hold visa subclass 600. The tuition fee waiver is in recognition of the current situation in Lebanon and will apply for a twelve (12) month period. The tuition fee waiver will be extended if a child transitions to a humanitarian visa offered by the Australian Department of Home Affairs.

If your child holds a refugee or humanitarian visa

The NSW Department of Education will waive the tuition fee for children from Lebanon who hold a refugee or humanitarian visa (visa subclasses 200, 201, 202, 203, 204, 449, 785, 786, 790, 866). The tuition fee waiver is in recognition of the refugee/humanitarian situation of the child. The tuition fee waiver will apply for the duration of the visa issued by the Australian Department of Home Affairs.

English support for your child

The NSW Department of Education provides English as an Additional Language or Dialect (EAL/D) support to develop English language competence so your child can fully participate in schooling and independently pursue further education and training. The department provides EAL/D support in primary schools, high schools, Intensive English Centres and the Central Sydney Intensive English High School. The availability of EAL/D support in primary schools and high schools will vary between schools, and will depend on the number of EAL/D students enrolled, and the resources available. Access to EAL/D if your child holds visa subclass 600

English as an Additional Language or Dialect (EAL/D) support is generally not available for students who hold visa subclass 600. The NSW Department of Education will waive this access restriction for newly arrived children from Lebanon who hold visa subclass 600. The access restriction waiver is in recognition of the current situation in Lebanon.

Community language programs

Some primary schools provide community language programs in over 60 languages spoken in the Australian community. These community language programs vary between schools, and the availability of particular languages will depend on the number of students who wish to study them. How to apply to enrol your child in a NSW government school

This fact sheet explains the process of how to enrol your child into a NSW government school.

Step 1: Apply online

All temporary residents seeking to enrol in a NSW government school must lodge their application online with the Temporary Residents Program. The application process can commence once your child arrives in Australia and has an Australian residential address.

Please visit deiparent.det.nsw.edu.au/#/login to lodge your application through the NSW Government Schools - Online Application Portal. If you require technical support with the online application, call 1300 615 199. Support is available from 8.30am to 5.00pm Monday to Friday (Sydney time) and is not accessible from outside of Australia.

Step 2: Assessment

After you lodge your application online, the Temporary Residents Program will assess your application and validate your child's visa. Check your email regularly for communication about the status of your application.

Step 3: School placement

After the assessment stage is completed, you will be sent a school placement request via the Online Application Portal. The school placement provides you with the opportunity to select a school from your in-area catchment. If your in-area school is at capacity and has no available place for your child, you will be offered an option to select schools outside your catchment. Please note, temporary residents are not eligible to enrol in selective high schools including agricultural high schools, the selective component of comprehensive high schools and Opportunity Classes (OC) in primary schools.

Step 4: Arrange a meeting with the school

After you submit your placement request via the Online Application Portal, contact the school and make an appointment for a meeting. On the day of the meeting, take the passport for each family member and the visa for each family member. The school may also ask you to bring evidence of your residential address and evidence of your child's immunisation status.

Step 5: School accepts the placement offer

After the school accepts the placement request, the Temporary Residents Program will issue an Authority to Enrol to the school. The Authority to Enrol provides the NSW government school with your child's enrolment start date. Your child cannot enrol in any NSW government school for any period unless an Authority to Enrol has been issued to the school by the Temporary Residents Program. Check your Online Application Portal regularly for communication about the status of your application and the next steps for enrolment.
