

TEMPORARY RESIDENTS PROGRAM

Fact sheet: Exemption for 482 visa in a regional school

This fact sheet contains information about the tuition fee structure for temporary residents holding visa subclass 482 and attending an eligible regional NSW government school.

Introduction

The NSW Department of Education supports Commonwealth and State initiatives for workers in regional and remote NSW. From the start of the 2025 school year, if a student holds visa subclass 482, and resides in an eligible NSW region, and attends an eligible regional NSW government school, they may be eligible for exemption from the Temporary Residents Program tuition fee.

Eligibility criteria

- 1. The student must hold a valid Temporary Skill Shortage (TSS) visa subclass 482, and
- 2. The student must reside with the sponsored parent who is the primary 482 visa applicant, and
- 3. The student and sponsored parent reside in an eligible NSW regional postcode (see below), and
- 4. The student must be enrolled at, and attend, an eligible regional NSW government school.

Effective date

The exemption applies to students who satisfy all criteria, and applies to eligible students from the start of the 2025 school year. The exemption does not apply to prior calendar years.

Residential address postcodes eligible for the exemption

To be eligible for the exemption, the student must reside with the sponsored parent who is the primary 482 visa applicant at all times, and the student must reside in a residential address with an eligible NSW regional postcode from the table below. NSW government school postcodes eligible for exemption

To be eligible for the exemption, the student must be enrolled and attend a NSW government school with an eligible NSW regional postcode from the table below. To find the address for a school, please visit schoolfinder.education.nsw.gov.au

Proof of residential address

The NSW Department of Education requires applicants to declare the accuracy of their claim for a regional residential address, and that they satisfy all the criteria of the exemption. The exemption will be cancelled where information is omitted, or false, or misleading information is provided to the Temporary Residents Program. Where an exemption is cancelled, the enrolment may be terminated, and the NSW Department of Education may commence legal proceedings to recover the tuition fee.

Change of residential address

The NSW Department of Education requires applicants to immediately inform the Temporary Residents Program if there is a change to the residential address of the student, or the sponsored parent who is the primary 482 visa applicant.

Exclusions from the exemption

Does not apply to the application fee

The exemption does not apply to the Temporary Residents Program application fee. The application fee remains payable on initial enrolment.

Does not apply to all visas

To be eligible for the exemption, the student must hold a valid Temporary Skill Shortage (TSS) visa subclass 482. The exemption does not apply to any other visa subclass. If the student changes visa, the exemption will cease from the end of the 482 visa and the parent will be sent a tuition fee invoice for future enrolment periods.

Does not apply to bridging visa holders

The exemption does not apply to a student holding a bridging visa subclass 010-070 where the student previously held a 482 visa. The exemption does not apply to a student holding a bridging visa subclass 010-070 where the student is applying to the Department of Home Affairs for a 482 visa.

Does not apply to all schools

To be eligible for the exemption, the student must be enrolled and attend an eligible regional NSW government school. If the student transfers to a non-regional designated school, the exemption will cease from the date of last attendance at the eligible regional school and the parent will be sent a tuition fee invoice for future enrolment periods.

Does not apply unless living with the sponsored primary 482 visa holder

To be eligible for the exemption, the student must reside with the parent who is the sponsored primary 482 visa applicant at all times. The residential address of the student and the sponsored primary 482 visa applicant must be an eligible NSW regional postcode.

Does not apply to residents of other states or territories

The exemption does not apply to students residing in any state or territory outside NSW. The exemption will not apply to students residing in the Australian Capital Territory, or bordering states of Victoria, Queensland, or South Australia.

Does not apply to additional voluntary school contributions

The exemption does not apply to voluntary school contributions. NSW government schools may request voluntary school contributions and charge additional fees for certain subjects or optional extension activities. Voluntary school contributions apply to all students, including Australian citizens, permanent residents, 482 visa holders, and other temporary residents in NSW government schools.

Refund of tuition fee overpayments

If a student has already made a partial payment toward the 2025 tuition fee and is assessed as eligible for the exemption, the Temporary Residents Program will review the tuition fee payment and contact the parent of the student to discuss refund options.
